In consideration of the acceptance of this credit application by Great Southern Fuel Supplies, we the applicants agree that the following GENERAL CONDITIONS shall apply to all petroleum products supplied on credit including that represented by the present debt owing by the applicant the company or the partnership to Great Southern Fuel Supplies

We also acknowledge that this application may be accepted by Great Southern Fuel Supplies with or without special conditions and notwithstanding acceptance Great Southern Fuel Supplies always reserves the right to refuse to supply any petroleum products on credit with out explanation.

GENERAL CONDITIONS

1. The liability for payment of the purchase price of all petroleum products supplied on credit shall reside with the applicants as well as the company or partnership as principal debtors.
2. The liability of each of the applicant(s) and the company and /or partnership to Great Southern Fuel Supplies shall be joint and several.
3. The due date for payment shall be 14 days from end of month in which the petroleum products are supplied by Great Southern Fuel Supplies to the applicants the company and /or the partnership
4. Great Southern Fuel Supplies reserves the right to charge interest at the rate of 3% per fortnight on all outstanding monies calculated from the due date of payment.
5. On the due date for payment and there after Great Southern Fuel Supplies invoice shall be conclusive evidence of the monies due and payable and the applicants the company and /or partnership shall not be entitled to deny that the goods and or services referred to in Great Southern Fuel Supplies invoice were supplied or that the monies are due and owing and Great Southern Fuel Supplies shall not be required to accept and credit refund or return after the due date for payment.
6. In the event that the applicants or company is the trustee of a trust the applicants warrant that the trustee has the right of reimbursement from the corpus of the trust fund of the relevant subject trust.
7. The applicants acknowledge that it is an offence against the Corporations Law for an officer of a corporation to allow it to incur debt unless it to pay all of its debts as and when they fall due.
8. Title to the fuel supplied on credit will not pass to the company /or partnership until the price has been paid in full.
9. Until title to the fuel passes to the applicants company / or partnership:
 - 1) The applicants the company /or partnership shall hold the fuel in a fiduciary capacity for and on the behalf of Great Southern Fuel Supplies
 - 2) The applicants the company /or the partnership may sell the fuel to a third party for the value in the ordinary course of business provided that
 - a) If the third party has paid for the petroleum products the applicants the company or partnership shall hold the proceeds in trust for Great Southern Fuel Supplies
 - b) If the third party has not been paid for the petroleum products the applicants the company or the partnership will on demand assign to Great Southern Fuel Supplies its right of action against the third party
10. The applicants on behalf of themselves and the company and or partnership hereby charge with the payment if the purchase price of the fuel supplied on the credit has not been paid, all property owned by any of them separately or together or in which any of them have an interest. Including land and leaseholds interest, whether the property is now presently owned by any of them or is subsequently acquired and consent to the registration of an absolute caveat over the applicants land interests to be registered at the legal cost of the applicants the company or the partnership as the cause maybe.
11. The applicants the company or the partnership shall pay Great Southern Fuel Supplies all cost and expenses of and incidental to recovery of any monies due and payable including legal costs on a solicitor own client basis
12. The law applicable to the supply of goods on credit shall be the law of Western Australia.
13. Time shall be of the essence as to the time for payment for goods or services supplied.
14. The applicant (s) covenant that they are and duly authorized to bind and do hereby bind the company/or partnership to the terms contained in these special conditions.
